4. PRESENTATION FROM NICK HOLMES – Rowington Parish Plan representative Nick Holmes gave an interesting presentation on the Rowington Parish Plan experience to date. Initially a public meeting had been held to gauge interest, from this a Steering Group comprising 3 Parish Councillors and 7 members of the public had been formed. Lottery funding, from Awards for All, to the tune of £4,000 had been secured and it was anticipated that this would all be spent. A large portion had been on a survey hand delivered to each of the 400 households. A 20% response had been received. A year on these responses were being categorised and would be presented to a public meeting in the new year. The Steering Group met once a month and it was anticipated that a further 6 meetings would be needed before the Parish Plan was finalised. Main advice was 'keep it simple'.
