The Parish Council voted against the proposal and it was rejected.

Lapworth had been identified as a category 1 village and earmarked for 100 new dwellings over the next 18 years. This would necessitate redefining the Green Belt area in Lapworth with some areas becoming 'white land' which could be used for the development of new properties. The Parish Council was encouraged to give suggestions of areas that could be designated as 'white land'. Cllr Mrs Francis queried whether the land that had already been designated as 'white land' had been taken in to consideration.
