4. PRESENTATION FROM PCSO CARL WHITEHOUSE

PCSO's Carl Whitehouse and Nathan Parry Hall were in attendance at the meeting. Following a brief introduction PCSO Whitehouse gave an overview of incidents reported within the Parish since 1st October. Sixty seven in total the most common were road traffic offences and thefts. The police were aware of trouble spots and monitoring both parking and youths congregating. More active traffic monitoring would be taking place in the near future. The Police were aiming to raise awareness of their presence and were 'walking the beat' as well as having a presence in the Police Post for a couple of hours on a regular basis. Concerns were expressed about 'pavement parking', and it was suggested that the police website could be updated. Parish Councillors expressed their appreciation of the Police's efforts and 'the Week that Was'.
