13. LAPWORTH RECREATION SITES

- Toilets the toilets were scheduled to close on 1st November, after a successful season.
- b. Travellers/Gypsies had camped over in Brome Hall one weekend and some mess was made in the toilets. Cllr Mrs Francis queried the availability of camp site facilities for them. D Cllr Caborn advised there were currently none in Warwick District and it was extremely difficult to make sites available to meet all criteria imposed by Central Government.

15. ROADS & PUBLIC RIGHTS OF WAY - General highway issues

- a. **Chessetts Wood Road** pothole update Councillor Corney advised these had now been marked up.
- b. **Temporary Closure Spring Lane, Lapworth** from the junction of Wharf Lane to the junction of Church Lane, on 12th October 2009, for a period of 5 days. *However it is anticipated the work will only take 1 day.*
- c. **Temporary Closure Grove Road, Lapworth** from the junction of Grove Lane for a distance of approximately 300m in a northerly direction, for a period of 5 days commencing on12th October 2009. *However it is anticipated the work will only take 2 days within this period.*
- d. **The Boot Bonfire Party** This was scheduled to take place on Thursday 4th November. The police were proposing to to close part of the Old Warwick Road and reroute traffic. Parish Councillors noted the proposal. It was suggested that the Village Hall Committee could charge for use of the car park on the evening in question. Councillor Lewis undertook to relay the suggestion to the Committee.
- e. Review of C and D roads Councillor Mrs Compton advised that a county wide review of C and D roads was scheduled to take place. Also a review of the changes implemented on A and B roads was to take place to see if there was any difference to the accident rates and public perception. Mobile flashing speed aware signs would be put on in various locations for six month periods.
- f. A complaint had been received from a resident of Glasshouse Lane regarding the large scale burning of waste. This had been referred to the Environmental Health Department of the District Council.
