MINUTES OF THE MEETING OF LAPWORTH PARISH COUNCIL HELD ON MONDAY 12th SEPTEMBER 2011 AT LAPWORTH VILLAGE HALL, OLD WARWICK ROAD, LAPWORTH

2. **DECLARATION OF INTERESTS**

3. **PUBLIC OPEN FORUM** –

- a. Local residents expressed concern regarding planning application **W11/0938 replacement stables at the Spinney** particularly in relation to new gates and a paved driveway. The applicant was present and advised that the planning authority had told him he did not need permission to erect new gates.
- b. Residents of **Bakers Lane** expressed concern regarding **new gates and fencing** opposite the Heronbrook Estate. Advice had been sought from the District Council but it was advised that no planning infringement had taken place. It was suggested that the residents talk to the landowner to see if a more sympathetic fencing and planting scheme could be put in place. The Parish Council undertook to raise general concerns regarding replacement fencing and hedges at the Planning Forum.
- c. Residents of Aylesbury Lane, Parish Councillors from Hockley Heath and representatives of Right Start were present in relation to the **Aylesbury House proposals**. A request for details on getting tree preservation order was made clerk to respond. To date no planning application had been made so the Parish Council was unable to comment on them but appreciated the concern of local residents.

- a **Aylesbury House Hotel** concern from individual residents and a 'No Start Group' had been received regarding the proposal from Right Start to apply for planning consent to make the former hotel into a drug rehabilitation centre. The majority of Councillors had attended the presentation by Right Start the previous week but had been advised that the planning application might not be lodged for up to 12 weeks.
- b. **Speeding along Old Warwick Road** and Speed Cameras Mr Coverdale had written expressing his worries regarding speeding traffic on the Old Warwick Road. It was agreed additional 'Wheelie Bin Stickers' would be requested; a further Speed Awareness exercise with the use of speed guns be undertaken clerk to arrange training and invite Mr Coverdale to support the action and advise Mr Coverdale of the date for Community Forum.
- c. Concern re use **Navigation by motorcyclists** Cllr Mrs Compton advised that about 26 motorcyclists had been at the Navigation two weeks ago and six the previous week and she had requested that Sally Rolfe of the Police Road Safety team visit on a Wednesday evening.
