- a. Rural Footway Lighting request from District Council to reconsider decision not to make a contribution to replace concrete columns. The Parish Council confirmed its decision not to make a contribution to the replacement concrete columns. Clerk requested to write to the District Council to advise that no allowance had been made in the budget for this expenditure and that it believed that some Parishes had been advised that it was not necessary to make a contribution.
- b. Warwick District Local Plan 3 letters of concern received from local residents. The District Council proposals for development in Lapworth are to be considered by the District Council Executive Committee, n 4th June 2013, after which there would be an opportunity to for all interested parties to register their views with the District Council. Cllr Mrs Lester advised that the post office was for sale and if a buyer was not found could jeopardise the future of the post office. It was queried whether this would alter Lapworth's 'category 1' banding. The clerk was requested to write to the Head of Development Services to formally challenge the category 1 status as it was believed that the other villages in that category had far more facilities.
