MINUTES OF MEETING OF LAPWORTH PARISH COUNCIL HELD ON MONDAY 13th APRIL 2015 AT LAPWORTH VILLAGE HALL, OLD WARWICK ROAD, LAPWORTH

2. **DECLARATION OF INTERESTS**

- Register of Interests: Cllr Child declared an interest in Rowington PCC
- b. to declare any personal interests in items on the agenda: Cllr Corney declared a personal interest in item 17.a as a member of the congregation
- c. to declare any prejudicial interests in items on the agenda and their nature (Councillors with prejudicial interests must leave the room for the relevant items).
- 3. **DORRIDGE FUN RUN** Representatives Steve Street and Nick Chadaway attended the meeting and advised that although alternatives had been looked at they had not identified a more suitable option than the current route through Lapworth. The Dorridge Fun Run had been going for over a decade and raised approximately half a million pounds. However they continued to try and minimise disruption by improving communications, minimising road closures and trying to accommodate all requests to get in and out. A team of local cadets would help in the litter clear up operation again to try and minimise the impact and inconvenience for Local residents. Representatives from the Parish Council appreciated the fund raising efforts but were of the opinion that the Dorridge Fun Run would be better routed through Dorridge. A suggestion was made that a contribution be given to the Lapworth WI to support their bulb planting project.

- a. Chris Jacob of St Giles Church was present to request the PC's support in relation to an application for a graveyard extension with upright headstones. Mr Jacob was advised to wait until the new District Council had been elected before submitting the application.
- b. Gillian Whitehead was present to request the Parish Council's support in securing the replacement of a dead tree at the junction of Kingswood Close/Station Lane. It was agreed that the Clerk would contact Tony Hemming of WCC and seek advice from the tree wardens.
- c. Peter Hill of Lapworth Local History Group was present to express concern regarding the reduction in useable surface area of the newly replaced Parish Noticeboards. Whilst the boards themselves are believed to be the same size as the old ones it was acknowledged that the new sturdy frames put around had reduced the useable area. The Clerk was requested to put an article in the Parish Magazine reminding residents that the boards were for the use of the Parish Council and other not for profit local organisations and requesting that the use of A5 notices be considered and that advertising materials were removed once past the date of the event.
