9. WARWICK DISTRICT COUNCIL

- a. **Report from Warwick District Council** Cllr Whiting advised that the District Council was in the process of considering its budget proposals for 2016/17 and waiting for further detail from Central Government in relation to the funding to be awarded for that period. It was anticipated that it might be necessary to raise the District Council's proportion of the Council Tax charge by 1.99% this would be the first increase in a number of years. There was the potential for the current taxi token scheme to be reviewed for the year ahead. The Local Plan was still in suspension pending proposals to meet the critical issues relating to Coventry's unmet housing need. It was not anticipated that the revised housing figures would impact on allocation for Lapworth. Planning Applications being submitted for consideration should continue to be considered in line with current guidance and principles.
