16/7/4 **Public Participation** – Queen's Birthday celebration. Julia Saunders in attendance offer to fund the planting of a tree on the green opposite the Oaks. Suggestion put forward for a weeping cherry, surrounded by a tree guard and snowdrops.

Sandra Hamilton querying at which stage Chessetts Wood Road became designated as an option for limited 'infill' sites. This proposal has been included in the emerging local plan which has been put forward to the inspector. Infill has to be between two houses and no more than two properties.

It was RESOLVED to approve the minutes of the Ordinary Parish Council Meeting on 13th June 2016 as a true and complete record of the meeting.

16/7/6 Reports for Information

Warwick District Council

The Local Plan

The revisions to the local plan were submitted to the Inspector on time, on 3 June. The Inspector has confirmed receipt, and in turn requested a significant amount of additional detail concerning the new sites that have been identified. This is in the process of being collated by WDC officers. Yet to receive confirmation of the new timetable, but previous indications were that the new public examination would begin in late September, and continue until December. If this submission is successful, hoped to have a new Plan in place during Q1 next year.

Other major issues

Leisure Centres - In the process of finalising plans for the major investment in our leisure centres in Leamington and Warwick (Kenilworth will follow later). A contractor

has been chosen. The scheme will see well over £10 million invested in the sites at Newbold Comyn and St Nicholas' Park. Separately, we are awaiting responses to our tender for the management of all of the leisure facilities in the District.

HQ relocation - plans continue to progress for the relocation of the Council offices from Riverside House to the Covent Garden site in Leamington. The relocation itself should be cost-neutral, but the council will have to invest several million in the rebuilding of the Covent Garden multi-storey car park.

Councillor Mrs Gallagher advised that a system of not displaying Planning Notices outside proposed developments was being trialled. Councillor Mrs Gallagher offered to set up meeting with the Head of Development Services, Tracy Darke, and the Chairman of Planning, Cllr John Cook, in relation to planning matters for interested Parish Councils..

b. Warwickshire County Council

Councillor Mrs Compton advised that the finance has been agreed for the roadworks at Stanks Island over the A46 with Highways England and IBM providing investment. A meeting will be held in September to discuss the planned work in more detail and the parishes will be invited. This would include Lapworth. Councillor Mrs Compton to advise of the date. Hatton residents concerned re queuing traffic.

Email from Police and Crime Commissioner set out aims and ambitions to make communities safe, wants to listen and engage with Communities. Cllr Mrs Compton asked what were priorities for Parish Council – traffic, rural crime, parking around schools, local visibility.

£4,000 in delegated transport budget remained if Lapworth could put forward any proposals for any small scheme. Packwood Road speed limit sign had been approved and funded.

options there are for managing/rerouting traffic in the area. No signs to be put up and boulders were not suitable. **Action** Clarify situation with Peter Hallam regarding rocks/logs on verges and action that should be taken
