16/6/4 **Public Participation**

2 members of the public expressing concern and asking for traffic monitoring on the Old Warwick Road by Packwood turning

4 members of the public to raise objections to W16/0913 and W16/0990 Kier Price from Spitfire Development re proposals to develop Aylesbury House site. Mrs Croft presented the concerns outlined in her letter dated 7th April 2016 – item 7a on the agenda.

16/6/5 **Minutes**

It was RESOLVED to approve the minutes of the Annual Parish Council Meeting on 9th May 2016 as a true and complete record of the meeting. Cllr Mrs Toogood was thanked for taking minutes in the absence of the Clerk

16/6/6 Reports for Information

- a. **Warwick District Council** Cllr Mrs Gallagher reported that cuts in funding from Central Government were placing increasing needs for savings at the District Council. On future should a replacement bin be requested as a result of damage or loss there will be a charge for replacement bins and bags.
- b. **Warwickshire County Council** Cllr Mrs Compton reported that the AVIVA cycle race was scheduled to come through Kenilworth and Leek Wotton on 16th June. Bus timetables were made available, and will be placed on noticeboards, to encourage use of the flexibus service as travel tokens are withdrawn. The service is subsidised by WCC and bus passes may be used on the service. However if usage drops it may not be feasible to continue.
- c. Warwick Rural West Community Forum report from Councillor Child circulated

- a. Letter from Mrs Croft regarding concerns relating to
- Parking on Station Lane/Old Warwick Road concerns about this junction had recently been investigated by WCC when the signage at Old Warwick Road was reviewed. Yellow lines were not feasible with so many residents,
- School traffic The County Council is currently discussing traffic management options with Lapworth School
- Potholes Station Lane Peter Hallam visited and some work expected but scale and timing unknown at this stage
- Damage to verges Station Lane reminder that responsibility for repairing verges after work on properties lies with the landowners
- Ball games Lapworth Oaks The Parish Council has put in feature and 'no ball games' sign to try and deter ball games due to concerns regarding safety.
 - Canal Bridge, Rising Lane limited visibility noted

- a. Housing Needs Survey it was proposed to accept and endorse the Housing Needs Survey dated June 2016. Clerk to put link on intranet and send copy to Local Plan team. 230 replies (30%) identified local requirement for 5 new properties.
