It was RESOLVED to approve the minutes of the Ordinary meeting of 8th May 2017 as a true and complete record of the meeting subject to amendments raised by Cllr Corney and Cllr Cooke, noted by the Chairman.

17/6/6 Reports for Information

a. Warwick District Council

Cllr Whiting reported that with regard to finance there was a very modest surplus for year end April 2017/18. However the challenge will be for the following year to make savings of over £200,000. There is a seasonal lull so not a lot to report. The Leisure Centres are progressing despite delay and extra cost. Everyone Active has taken over the running of the leisure facilities. Kenilworth facilities are to be upgraded. All parishes are to be invited to meet Cllr Rhead to discuss traveller and gypsy sites – date to be advised. There is concern over the number of nail bars in Warwick District – working conditions to be scrutinised. No more news on the Local Plan but WDC are anticipating a large number of planning applications once the Inspector approves the Plan.

b. Warwickshire County Council

Cllr Cooke reported that there are now 57 seats following re-organisation, previously 62. Following the election the Conservatives have 36 (a majority of 19), Labour 10, Lib Dems 7, Green Party 2, Whitnash Residents 1 and Stratford First 1. Following the AGM the Leader is Cllr Izzi Seccombe, Deputy Leader (Finance and Governance) Cllr Peter Butlin, Chairman Cllr Clive Rickhards. The Cabinet Portfolio Holders are Adult Social Care and Health Cllr Les Caborn, Fire and Community Safety Cllr Howard Roberts, Customer and Transformation Cllr Kam Kaur, Education & Learning Cllr Colin Hayfield, Children's Services Cllr Jeff Morgan, Transport Cllr Alan Cockburn, Environment Cllr Jeff Clarke. They have to run a budget from the previous administration with a deficit of £67m. There is to be a presentation to the County Council to which parishes will be invited regarding travellers later this month.
