17/9/4 Public Participation –

Residents of Spring Lane were present to express concern in relation to a drainage dispute with their neighbour. They had received advice from the Environment Agency, Warwickshire Highways and Building Regulations.

Residents of Chessetts Wood Road were present to register an objection to planning application W17/1114 135 Chessetts Wood Road. Main tenants of objection were that the proposed development was not in keeping with the street scene, which was a run of attractive Victorian properties, secondly the development was on a very dangerous bend which is exacerbated by lorries and vans during any construction works.

It was **RESOLVED** to approve the minutes of the Planning Meeting of 7th August 2017 as a true and complete record of the meeting.

17/9/6 **Reports for Information**

a. Warwick District Council

Local Plan - due for adoption by Council resolution on 20 September. CIL Levy will be subject to a separate report in November giving a transparent mechanism whereby the levy costs could be calculated.

HQ relocation - planning applications being submitted for Riverside House (outline, to be redeveloped as housing) and Covent Garden (detailed, new Council HQ offices, apartments, and replacement larger multi-storey car park). Completion of Covent Garden site scheduled for early 2020.

Leisure Centres - Some facilities (including pool, gym and studios) at Newbold Comyn now open. Sports Hall at St Nicholas Park now open, pool re-opens (ahead of schedule) on 21 September. Other works badly delayed by various issues related to utilities and their subcontractors. Costs increased, but hopefully scope for at least partial recovery.

Gypsy & Traveller Sites - Special Planning Forum taking place at Leamington Town Hall, Thurs 14 September - invitations sent to PCs. Cllr Henderson attending.

Finance - Q1 showed WDC finances broadly in line with budget (modest surplus, but early in the year). £200,000 deficit currently projected for 2018/19, so work required to bridge this gap.

b. Warwickshire County Council

Wharf Lane A resident of Wharf Lane has asked for a speed limit reduction in Wharf Lane from 60 to 40 mph.

However, a speed survey will need to be taken to determine whether or not there is a case. The residents affected do not live in Lapworth & West Kenilworth so liaison has been taking place with neighbouring colleague councillor John Horner.

Children Centres - The consultation on the WCC proposal to reduce the number of Children Centres in the County in order to meet an agreed 1.1million pound budget cut continues. Kenilworth County Councillors will be joining force to oppose this reduction to Children's services in Kenilworth & surrounding areas. A well attended public meeting took place at St John's Church in Kenilworth.

Cllr Jeff Morgan portfolio holder for Childrens Services said:-

"We are getting a huge response to our consultation on 0-5 services with over 1000 responses and the closing date isn't until 11 September.

In order to make sure we consider everyone's views and to give time for officers to do a good job on the paper, we will have to push back the timescale a little. So, the target is now to get Young People's Overview & Scrutiny Committee to consider this in October prior to the paper going to cabinet for decision in November."

One in Three Electric Blankets Failed Safety Checks - Warwickshire County Council Trading Standards is launching its annual electric blanket safety testing campaign. Have your electric blanket safety tested FREE of charge this coming October.

In 2016, one in every three of the electric blankets tested failed and faulty electric blankets are a known cause of house fires.

The service is also offering to safety test kettles, irons, toasters and Christmas lights (again, free of charge) at the same time.

Free electric blanket safety checks will take place at venues across all five districts and boroughs this coming October. Safety tests will be carried out by an expert electrical examiner. Wednesday 4th October: Leamington Town Hall.
