Warwick District Council In addition to the Assembly report, Cllr Mrs Gallagher put on record her thanks to the District Council's refuse and recycling team for their tireless efforts to maintain the service during the adverse weather conditions. The Parish Council endorsed this sentiment and the Clerk was asked to write to the District Council. The official opening of St Nicholas Pool, after its refurbishment, is scheduled for 21st April's, however the pool is open to the public 24th March 2018.

County Fire Services

Discussions are taking place between West Midlands and Warwickshire Fire & Rescue Services about future joint working arrangements. Discussions are at an early stage, but Warwickshire is the smallest fire service in the country and there is potential for an improved service. We will have to see if talks prove fruitful.

2018/19 Council tax and spending

Our new One Organisational Plan from 2017-2020 underpins how WCC will continue to transform to meet the changing needs of our communities. We are doing so while having to make an extra £67 million in savings by 2020.

We have streamlined our priorities and are focusing on helping people remain safe, healthy and independent. This includes concentrating resources on those that are most in need, people in receipt of social care and our young people, particularly those in care. This activity needs to be underpinned by a strong economy, our second priority.

WCC's share of council tax has risen by 4.99%. This comprises a basic 2.99% rise as well as an extra 2% increase that the government allows us to levy to help us fund social care. So, for a Band D property, the annual Council Tax bill is now £1,363.68, an increase of £1.25 per week on 2017/2018's bill.
