# **Lapworth War Memorial**

This year Remembrance Sunday and Armistice Day are coinciding and it is the 100<sup>th</sup> anniversary of the end of WW1. To reflect and support the occasion it was proposed to clean war memorial in time for the service, quotes had been sought

- 1. £350 steam clean war memorial
- 2. £780 repointing and cleaning slabs round war memorial.

There was the potential for the PCC to make a modest contribution circa £250. It was requested that the Parish Council pay for the works proposed.

It was also noted that the left hand post on the gates as you walk in was rotten and broken and would need maintenance to be done before 11<sup>th</sup> November 2018.

### **Parish Magazine**

The Parish Magazine changed to universal distribution in February 2017, as recommended within the Lapworth Parish Plan. Recruiting volunteer distributors had gone well and now nearly all residents with Lapworth receive a free copy of the magazine. However distributing double the amount of free copies had had a financial impact and whilst advertising income was growing there had been a one off shortfall in 2017. To rectify this the PCC had retendered the printing contact and managed to save 40% of the cost, had sought funding from other donations, asked for voluntary contributions which had been generously given and it was anticipated that the magazine was now on a sound financial footing. However there was still a gap in the 2017 deficit. A grant to support the transition to universal distribution was therefore requested.

### 18/9/6 **Reports for Information**

a. Warwick District Council

Cllr Mrs Gallagher had submitted a written report as follows

If I may I would like to start with an explanation as to why I have resigned from the Conservative Group, this was as far as I was concerned a matter of principle, in my view the Conservatives wanted to block a lease being extended for several charities in Leamington, I said that I thought it was wrong so they bought in a three line whip, which means you have to vote as the leader and whip tell you to, I believe this is not democratic and at Full Council I defied the whip and voted for the motion to extend the lease for the charities, we lost the vote as the 11 Conservative councillors that had originally supported the motion obeyed the whip, I was the only one to stick to my guns, now I am of course still your councillor, and until May of next year when we are all up for election I will still do my best for you and all my constituents in Arden Ward, unfortunately on Friday Cllr Mobbs felt it necessary to take me off all committees, and also remove me from being the Parish/Town champion which most people think is if nothing else personal and spiteful, I will almost certainly stand next May as an Independent as I believe that politics really has no business in district elections anyway.

Now for the main part of my report.

Heritage open days 13th-16th Sept 50 venues open to the public, brochures available from R/H visitor centre, and libraries.

Warwick Words Festival from 1st-7th Oct again tickets available from Warwick and Leamington visitor centres.

The community protection team is undertaking a survey on its effectiveness on dealing with noise, be it a barking dog, parties, or a rowdy neighbour, the survey can be found on WDC website and is open until Nov 9th.

I am sorry my report is so long this time but I felt it was important that you were aware of the facts, if anyone would like to contact me for any reason please feel free to do so either by email or telephone as always I am here to serve the residents of Arden Ward.'

b. Warwickshire County CouncilCllr Cooke submitted the following written report:

#### Kenilworth Station

Members will have read about the tragic death at the station. A man was hit by a train and pronounced dead at the scene. Police have not released further details.

I have also reported a noise nuisance at the station caused by squealing brakes and the Tannoy system. It appears that all the trains on the new service use the old design of braking system leaving residents suffering twice an hour with squealing brakes.

# Trees, Potholes & Resurfacing

Peter Hallam has been active throughout the Lapworth & Kenilworth area and his team have filled in a number of potholes and arranged for a number of hedges to be trimmed. He has even personally cleaned some signs!

I have also made further representations from a local resident regarding trees and hedges blocking various local footpaths. The District Council has trimmed most of these. A number of roads in Kenilworth have been surface dressed.

### Warwickshire stage of Tour of Britain 2018 hailed great success

Thousands of spectators lined the streets of Warwickshire to see top cyclists battle it out in the UK's most prestigious road race. The County's debut as stage-host for the OVO Energy Tour of Britain proved to be a huge success, with people flocking to see cycling's biggest names

tackle the 183.5km route. Reigning Tour de France and Giro d'Italia champions Geraint Thomas and Chris Froome were among more than 100 riders who burst into action. Nuneaton was the start for the star-studded line up of competitors and they were cheered on by a huge amount of spectators, making their way out of the town centre and heading through the county. Fans were treated to a gripping finale as the race came to a close in Leamington Spa in the final stretch along Newbold Terrace.

Leader of Warwickshire County Council, Cllr Izzi Seccombe, was delighted with how the day unfolded:-

"It's been a fantastic day for the whole county. When we learned that we'd be hosting the Tour of Britain for the very first time, we could not wait for this day to come, and I think it's exceeded all our expectations," said Izzi.

# 18/9/8 Items and Correspondence for Consideration and Decision

- a. To **consider** the Parish Magazine application for £1,000 grant funding. It was **RESOLVED** to make a one off grant of £1,000 towards the transition to Universal Distribution.
- b. To **consider** request for funding to support the War Memorial restoration. District Councillor Sue Gallagher made a generous personal donation of £350 towards the cleaning of the War Memorial, £250 was anticipated from the PCC. This would leave a balance of £530 to be funded. An application had been made to the WCC1 Commemorative Fund but as yet there was no indication as to whether it would be successful. The Parish Council **RESOLVED** to make up the balance, after any grant funding, to the outstanding £530. No contribution was agreed in relation to the broken gate post.
- c. To **consider** the Salvation Army request to site a clothing recycling unit at the Village Hall. It was **RESOLVED** not to agree to the request.
- d. To **consider** the proposal to develop a Lapworth Village Guide. An example f the Wootton Wawen Guide was circulated it was **RESOLVED** to research the potential for producing a Lapworth Guide. Cllr Henderson to approach Wootton Wawen as a starting point.

#### 18/9/9 **Progress Reports**

a. Village Hall Play Area Equipment progress report Cllr Rees. A funding request for circa £22,000 had been made to the Warwick District Council RUCIS fund and is being considered by the Warwick District Executive on 26<sup>th</sup> September.

Circa £16,700 section 106 funding is to be made available on sale of 50% of the houses at Kingswood Farm/Meadow House. Building expected to start this Autumn but no definite date has yet been set. The balance of the remaining £62,000 had been raised by Clare Shales seeking grants from both local and national charities and businesses. It was anticipated that the Parish Council's donation would be between £7,000 and £10,000. Thanks were extended to Clare on her remarkable perseverance and achievement.
