19/12/4 **Public Participation** – a member of the public Kathy Bains, representative of Walking Bus Group, reported that recently it had been very dangerous walking to school due to the diversion caused by the Old Warwick Road being closed whilst Severn Trent was undertaking repairs. The diversion was causing hazardous conditions for both children and parents and there had been a near accident in Station Lane. Cllr Rees undertook to contact Severn Trent the next day. It was noted that the traffic problems were not limited to the time during the diversion but were a consistent problem.

Cllr Doyle undertook to contact Community Speedwatch groups in Kenilworth and Burton Green who were carrying out speed awareness campaigns.

Lapworth Speeding on approach to the Boot Inn

Cllr Cooke reported that following a complaint from a local resident in July he had scheduled some works from his minor works budget to install wood effect gateway features, dragons teeth and 'Slow' markings to help emphasise the change in speed limit and give a visual impact to drivers who are entering into a more built up area and making it safer for persons to exit the pub access. The engineer involved left the employment of the Council and the paperwork etc was not passed on and as a result has led to a long delay in starting the works. The appeal is made by Mrs Annette Bucknall against the decision of Warwick District Council. The application Ref W/18/2324, dated 29 October 2018, was refused by notice dated 9 April 2019.

The development proposed is described as 'Alterations and conversion of existing brick and tile barn/stables to residential dwelling with associated access and parking'. The Appeal is dismissed

ii. **Green Acres, Church Lane, Lapworth, B94 5NX** The appeal is made under section 78 of the Town and Country Planning Act 1990 against a refusal to grant planning permission. The appeal is made by Jayne Crabb against the decision of Warwick District Council. The application Ref W/18/2375, dated 13 December 2018, was refused by notice dated 28 February 2019. The development proposed is described as 'Erection of two-storey side extension'.
