20/1/5 **Neighbourhood Planning** – David Butler, Business Manager, Policy & Delivery Warwick District Council gave an overview of the process, benefits and timescales of introducing a Neighbourhood Plan. Grant funding is available from Central Government, recent examples of local Neighbourhood Plans include Leek Wootton/Guys Cliffe.

20/1/6 **Minutes**

The minutes of the Ordinary Meeting of Lapworth Parish Council meeting on 9th December 2019 were agreed and signed as a true record. However it was noted that the concerns expressed re traffic on Station Lane were not just confined to the period that the Old Warwick Road had been closed by Severn Trent.

20/1/7 Reports for Information

Warwick District Council

After two by-elections in the last few weeks the political balance of Warwick District Council remains as it was and I am still a Chairman with a casting vote though I have not had to use it since the Annual Meeting in May.

Little has happened in the last month because of purdah during the General Election campaign and Christmas

Budget setting is imminent though the Government support announcement has was delayed by the Election and was made in a written announcement following the Queen's Speech.

There are some changes to RUCIS. The money is being pooled rather than two separate budgets for Rural and Urban and to reflect the climate emergency agenda greater emphasis will be placed on the environmental benefits of schemes. The RUCIS £150,000 would no longer divided between rural and urban areas, schemes with environmental benefits could benefit from a 90% grant rather than 80%.

WDC Climate Emergency declared with the aim to be carbon neutral by 2025.

b. Warwickshire County Council

For clarification it was advised that kerbed stretches of road are a District Council function.

Stanks Island

Traffic management is to be put in place to enable the essential works on the Stanks Island and Birmingham Road improvement scheme to be carried out safely.

From 13th January 2020 until Spring 2020, the following Temporary Traffic Orders will be in place:

- 1. **Wedgnock Lane southbound** will be closed 24 hours a day, 7 days a week, from its junction with Cape Road to Wedgnock roundabout.
- 2. **Westbound traffic on the A425** will no longer be able to turn right onto Wedgnock Lane and will be diverted around Stanks Island and back where turning left into Wedgnock Lane is permitted. This will be in place 24 hours a day, 7 days a week.
- 3. **Traffic from Budbrooke Road** will be banned from turning right onto Birmingham Road from 9.30am until 3.30pm Monday to Friday if temporary signals are in use. During this time traffic will be diverted around Stanks Island and back. Without this ban, 3-way temporary traffic signals would be required which would cause significant delays to the network.
