6. Reports for Information

6.1. Warwick District Council

Although the Polling Stations have to be Covid-safe and in some urban areas this has needed venue changes, in this area the normal Village Hall Polling Stations will be open. Work continues to support businesses emerging from Covid restrictions including financial support, licensing and other measures. *Pass on appreciation of officers to VH Committee*.

A court case to define "place" may enable the continuation of virtual local government meetings. The Ministry has provided evidence in support. A decision is due on 21st April. In case there is no helpful decision the Annual Meeting of the District Council will now be 5th May.

Work has started on a joint Local Plan with Stratford and there will soon be a search for possible development sites as an early input.

Warwick District Council have continued to distribute the grants to local business, through our various schemes, and today have started to pay the restart grants to business in the Lapworth area. We have also been working with local businesses about guidelines for them reopening and assisting them with any queries.

6.2. Warwickshire County Council

Residents struggling with energy bills can get help

The council's Local Welfare Scheme is offering a one-off payment to families and households finding it difficult to pay for fuel. Applications for the payment, in the form of a voucher, must be made by 16 April 2021.

Families and households in Warwickshire can apply whether they use pre-payment meters, pay by direct debit or on receipt of an energy bill if they can evidence eligibility through the impact of COVID-19 on their income.

Over 200 flyers had been delivered in Station Lane which had prompted 18 responses from potential volunteers. An early meeting had identified a number of areas that could be taken forward. These include the installation and care of planters, commissioning appropriate art works, noticeboards and cleaning and communications. There may even be options for repurposing the phone box. A further meeting is now planned to look in more details at the options.

9. Progress Reports

9.1. Lapworth Surgery/Volunteers - report dated 19th March 2021

At the vaccination hub we expect to have called all the over 50's within the next 2 weeks for their first dose. This will complete the 1st stage of the massive job asked of us in December and will mean over 20,000 of the people in our PCN will have had a first covid vaccine, most of these having been at Studley. This is a stunning success and the best, most important and most exhausting project I have ever been involved in!

At that stage we will be half way through the process and 11 weeks later we will complete our task as we go on to give 20000 second doses. This should coincide with the lifting of lockdown restrictions at the end of June if all goes to plan. In the first wave, 99% of all hospitalisations and deaths were in the over 50 age group and so protecting this group is hugely significant.

Our PCN has decided not to continue to vaccinate patients with no underlying health conditions who are under 50. This group will have the option of Stoneleigh or Millennium Point mass vaccination sites as well as various other vaccination sites locally in Warwickshire. These will most likely be in Stratford, Leamington and Kenilworth. Once the government opens these cohorts at the end of April then patients will be able to book their vaccine via the government

website. These patients are generally able to travel and there is more than enough capacity in the system to ensure they get their vaccines before the winter.
