Minutes of Ordinary Meeting of Lapworth Parish Council 14th June 2021

- 1. Apologies Cllr Child, Cllr Doyle, D Cllr Hales, C Cllr Cooke
- 2. **Declarations of Interest** none declared
- 3. **Dispensations** No requests received
- 4. **Public Participation** 3 members of the public present. One expressing concern re road surface outside Bearhouse Farm Mews which has caused vibrations over 3 ½ years. All passing traffic causes vibrations, throughout the day and night. In addition concerns re subsidence and risk of loads shedding from passing traffic.

WCC had visited the site and advised that the wrong surfacing had been used and needed to be resurfaced but a number of dates had been promised and missed. Discussion regarding drains by the Boot, it was queried whether they are cleared twice a year a frequently.

Speeding was also flagged as an issue, which compounds the problem. Queries raised as to the next steps and what was the plan to address speeding. Suggestion from the public that residents be asked to fund a speed camera, it was suggested that this had been done in other areas, or a fake speed camera. Frustration expressed that data gathered and speedwatch could lead to no action being taken.

It was confirmed that the process to be followed to gather data to support case for further action and checks in four areas had been organised by Cllr Cooke. Community Speedwatch was a positive step with data to support its success and training was organised for 5th July 2021. This initiative would have been up and running for 12 months but for the pandemic impacts.

Cllr Illingworth advised that the enforcement of speeding is entirely a police responsibility and therefore concerns should be raised with the police.

5. **Minutes** It was **RESOLVED** to approve minutes of the Annual Meeting of Lapworth Parish Council of 4th May 2021 Meeting, these together with previously agreed minutes of 2020 Meetings June, July, August, September, October, November, December and 2021 Minutes January, February, March and April and 2020 Parish Assembly were signed as a true and accurate reflection.

6. Reports for Information

6.1. Warwick District Council

Like many other organisations we await clarification on changes to the Covid rules and regulations which affect many aspects of the Council's work both internally and externally. Officers are investigating arrangements for more staff to be operating in Riverside House again. Smaller committees are already meeting in the Leamington Town Hall but a full Council meeting will necessitate a relaxation of the rules. In Leamington also Parade is about to open to traffic again.

Now that people are out and about in the fine weather we have a District-wide (actually nation-wide) problem with the amount of litter for disposal which far exceeds the capacity of the normal litter bins. Much of the litter is related to take-away food and drink under current hospitality arrangements.

There has been a further Zoom meeting with the officers and residents concerning developments at Bakers Lane and Glasshouse Lane. Solihull councillors are also now involved with Bakers Lane.

Birmingham Airport is to become the only airport other than Heathrow designated to accept flights from Red Zone Countries.

6.2. Warwickshire County Council

Have your say on Transport and Highways Services in Warwickshire

Feedback is being sought on a range of issues from the condition of roads and footpaths to the quality of cycling facilities across the County. The answers will be compared with the views of other members of the public across England and Scotland, as part of the National Highways and Transport Public Satisfaction survey.

Warwickshire County Council is one of 111 Local Authorities to sign up to a standardised survey that will ask members of the public exactly the same questions, whether they live in Cornwall or Northumberland.

The questionnaire will be sent to a minimum random sample of at least 3300 Warwickshire residents from 7th June, followed by a reminder, with local and national results to be published in late-October 2021.

Voluntary and community organisations are being encouraged to apply for grants from the Warwickshire County Council Councillors' Grant Fund to support projects that will benefit their community.

The Application window for the first round of funding from the Councillors' Grant Fund 2021/22 is open.

8. Items and Correspondence for Consideration and Decision

8.1. **Sites for Traffic Speed Monitoring**- confirmed as two speed checks on Station Lane carried out close to 69 Station Lane (approaching school area) and by 169 Station Lane (no pavement area) and on the Old Warwick Road by the timber yard and by the Bromehall Lane/Surgery entrances (busy stretches, close to canal bridge and to playarea and Village Hall).

Data should be available by mid July. Cllr Rees to summarise and data to be shared with Cllr Cooke and made available to support determination of the next steps.

8.2. **Parking on the Station Lane bend adjacent to Northern Boundary** - As part of the works, the existing School warning sign was changed on Station Lane to a new larger sign with a large yellow backing board so that it was clear to motorists that they were approaching a School. This sign is still there and clearly visible to motorists approaching the bend to the school on Station Lane. There is already a School Warning sign approaching the school area from the north. Speed checks were also to be carried out in this location.
